



Rules and Regulations of the Marketing Contest "[Contest Name]"

Article I.

Contest Promoter and Organizer

1. Article II.

Contest Duration and Venue

1. The Contest will take place from [Start Date] to [End Date] (hereinafter the "Contest Period").

Article III.

Conditions for Participation

1. Any natural person over the age of [e.g., 16 or 18] with permanent residence in the Slovak Republic may become a participant (hereinafter the "Participant"), provided they meet all the conditions set out in these rules.



2. Employees of the Organizer and their close relatives as defined in § 116 of the Civil Code are excluded from the Contest.
3. The conditions for entering the Contest are: a) Visit the Contest website during the Contest Period. b) Correctly and truthfully fill in all mandatory fields of the contest form/quiz. c) [e.g., Correctly answer all contest questions / achieve a minimum score of X points / creatively answer an open-ended question]. d) Submit the completed form/quiz. e) Give consent to the processing of personal data and agree to the contest rules.
4. Each Participant may enter the Contest only once. Multiple entries will be excluded from the draw.

Article IV.

Prizes and Drawing

1. The prizes in the Contest are as follows:

6. Prizes cannot be enforced through legal action, nor can financial compensation be demanded for them. The Organizer is not responsible for any tax liabilities arising from the receipt of a prize.

Article V.

Data Protection

1.
